### **Frontier brings low fares from Bismarck, N.D. to the West** *Nonstop flights to Denver as low as \$60\* each way at [FrontierAirlines.com](http://FrontierAirlines.com)*

**DENVER (Feb. 20, 2012)** – Frontier Airlines announced today that it is launching year-round nonstop service to Bismarck, N.D. (BIS) from its Denver International Airport (DEN) hub beginning May 17, 2012, with five weekly flights. Frontier is celebrating the new service with low introductory fares starting at \$60\* each way (taxes and fees included) available at [FrontierAirlines.com](http://FrontierAirlines.com).

"With the addition of this nonstop service to Denver, Frontier brings Bismarck its only low-fare option to the Mile High City and destinations throughout the West such as San Francisco and Seattle," said Daniel Shurz, Frontier's senior vice president, commercial. "In addition to our low fares, customers will connect to Denver and the west aboard our Embraer 190 aircraft, featuring leather seats, in-flight WiFi service and five rows of STRETCH seating, with an extra five inches of comfortable legroom."

"We are very excited Frontier Airlines will be joining our business community," said Kelvin Hullet, President of the Bismarck-Mandan Chamber. "It is an exciting time in North Dakota, and to add a low fare carrier enhances the business and leisure travel opportunities."

"We whole heartedly welcome Frontier Airlines to the Bismarck/Mandan market," said Greg Haug, Bismarck's airport manager. "We are excited about the opportunities Frontier Airlines will provide the traveling public and appreciate their willingness to provide competition in our market."

Introductory fares begin at \$60\* each way and are available for purchase at [FrontierAirlines.com](http://FrontierAirlines.com) through March 5, 2012, for travel through June 17, 2012.

#### **\*Terms and Conditions for Introductory Fares**

Tickets must be purchased by 11:59 p.m. Eastern time, March 5, 2012. Fares shown are each way for travel through June 17, 2012. Roundtrip purchase not required. A 14-day advance purchase is required. Seats are limited at these fares and certain flights and/or days of travel may be unavailable, especially during busy travel periods. Tickets are nonrefundable, but depending on the fare type purchased may be transferred for \$50 or reissued for alternate flights for \$50, as well as a possible fare increase to a non-promotional fare type. The name change fee and itinerary change fee are not exclusive of each other. Previously purchased tickets may not be exchanged for these special fare tickets. Flight segment(s) must be cancelled prior to scheduled departure time or the ticket(s) and all monies will be forfeited.

Fares shown reflect purchase at [FrontierAirlines.com](http://FrontierAirlines.com). Tickets purchased on Frontier's website and with Frontier's Reservations centers must be paid for at the time the reservation is made, but may be canceled for a full refund without penalty up to 24 hours after the time of purchase. Depending on the fare type purchased, a \$20 fee may be

charged each way for the first and for the second pieces of checked baggage. Fares shown include all fees and taxes and are subject to change without notice.
